## I. MEETING CALLED TO ORDER AND ROLL CALL

John Campbell, Chairman of the Design and Review Board, called the meeting to order. Board members Sandra Hull, John Campbell, Dick Kinder, and Keith Speirs were present at the meeting. # II. APPROVAL OF MINUTES

### DR-18-36.

Bill Baumgardner of Hutchison Signs requested sign approval for a wall sign and a window sign at 538 East Liberty Street in the C-4 Zoning District.
