

REQUEST FOR AUTOMATIC EXTENSION OF TIME TO FILE

This extension does not extend the due date for any estimated taxes or tax due for 2019.

1. I request an extension of time until _____, 2020 to file my City of Wooster income tax return for 2019.
2. The extended date requested should be no later than October 15, 2020.
3. No late filing penalty will be charged; however, penalty and interest shall be calculated on the amount remitted after April 15, 2020.

DECLARATION OF 2020 WOOSTER INCOME TAX ESTIMATE

Due on or before April 15, 2020

Extension of time to file a tax return does not apply to a declaration of estimated tax or payment of quarterly installments

The tax rate for 2020 is 1.5%. The City of Wooster allows 100% credit for taxes paid to another city up to 1.5%

5. A declaration of estimated tax should be filed, and quarterly estimates made for 2020, to avoid penalty and interest for any taxpayer required to pay 2020 estimated taxes. A taxpayer is required to pay estimated taxes if their tax liability, less credit for Wooster taxes withheld and/or taxes paid other cities, will equal or exceed \$200.
6. Total 2020 Wooster estimated taxes. (Total tax less estimated credit for Wooster tax withheld and taxes paid other cities.) \$ _____

2019 NON-RESIDENT INDIVIDUAL NON-FILING DECLARATION

Due on or before April 15, 2020

Non-residents who received a Wooster income tax return in the mail or filed a 2018 tax return and are not required to file a 2019 Wooster tax return, should complete this non-filing declaration in lieu of filing a tax return.
