

Upcoming Projects

Melrose Drive Improvements

The northern portion of Melrose Drive is scheduled for improvement in 2022. The improvements include curb and gutter, sidewalks, a bike path on the west side, a dedicated bus-stop near Melrose Trailer Park, and reconstruction of the roadway from Milltown Road to Smithville-Western.

Roadway Resurfacing - Beall Avenue, Cleveland Road, Columbus Avenue

You may have noticed the brick crosswalks on Beall Avenue in the College of Wooster vicinity were removed this summer. This was in preparation for the upcoming paving project. Hopefully, with the removal this summer, the ground will settle enough before the resurfacing to create a nice, smooth driving surface.

ODOT funding for the resurfacing project will cover about half of the \$1,050,000 estimated cost for the resurfacing of these three major city roadways.

Dix Expressway

ODOT is starting a \$31,000,000 reconstruction project in March 2022 on the Dix Expressway. The concrete will be removed and replaced with asphalt. The expressway will not be closed completely, but will be reduced to one lane.

Wastewater Recovery Facility Update

The open lagoons at our Wastewater Recovery Facility have been emptied and the new covered storage tank has been in operation since July. This storage tank can hold five million gallons and allows for gas capture, which lowers the noticeable odor that emits from the biosolids. The tank has simplified load-out features that enable the biosolids to be transported easier and with less smell for land application.



The construction of this storage tank took close to a year to complete and had a final cost of \$2,316,000. This investment shows a commitment to ensure sustainability and to meet the expectations of our community.

Clear Creek Park

The newest addition to Wooster's park system is almost complete. Grant money from NatureWorks and OPWC was used to create a 10-acre park on Venture Boulevard. The park has about a mile of paved walkway meandering through woods, creeks and hills, a deck overlooking Clear Creek, a restroom and a still to be installed pavilion and playground area. The pavilion is on a slow boat from Australia and we're hoping it finally makes it to Wooster in November.





Streetscape - Phase 3

The southwest quadrant of the square was finished just before Woosterfest this fall. This is the final piece of our updating of the downtown square to make it more inviting to our residents and visitors. The cannons were refurbished, the statue was powerwashed and seating areas were established.

Senior Hike and Stroll

The Senior Hike and Stroll Program saw a huge increase in participation this fall.

The Hikers met at Wooster Memorial Park and hiked for about 1 ½ hours on the trails. Recreation Manager Jeff Battig led 20 participants on the weekly hikes.

The Strollers met at various parks that had paved surfaces and walked for an hour. This program was developed for those who are still active but need more stable footing.

UPCOMING DEVELOPMENT



Wooster Innovation Park

The Wooster Innovation Park is welcoming an historic industrial expansion with the Wooster Brush Company breaking ground on a 608,400 square-foot single building, the City's largest-ever. The construction project will host upwards of 75 jobs, while at the same time, Scannell Properties works to complete its 200,000 SF distribution center, employing 150 workers. This development and it's resulting job growth are due to the City of Wooster purchasing 136 acres to expand the Wooster Innovation Park in 2020. The City is partnering with JobsOhio to internationally market the remaining 116 available acres for job-creating development.

Dominion East Ohio Gas is laying 6.4 miles of new pipe extending from Geyers Chapel Road to Mechanicsburg Road to provide increased capacity of natural gas for future development.

New Housing Options

Housing developments over the past few years have been sparse while Wooster's population is steadily increasing and we now have over 27,000 residents. Several developers are excited to bring new housing to the area. Lemmon Development is proposing 36 new houses, 16 new villas, and 8 senior apartments at Oak Hill Road, while its development partner, Vision, hopes to construct 236 new apartments on Oldman Road. The project will enable an expansion of the Wooster City School District's Oldman Road campus, and through a proposed tax increment financing arrangement, the new homes could cover the \$6.5MM cost of installing new roundabouts at Oak Hill/Oldman and Oak Hill/Milltown, in addition to reconstruction of W. Milltown and parts of Oak Hill along with sewer extensions.

Through three quarters of the year, the City's financial performance is very positive. The income tax receipts appear to indicate that the local economy is doing well. The lodging tax increase would be a sign of recovery to pre-pandemic levels. While the City receives zero sales tax, it does indicate that people are spending.

The increased tax revenue, when combined with spending below budgeted amounts, positions the City to operate efficiently and continue to invest in infrastructure and services. Stewardship of the public's funds remains a core value and goal of the City organization.
