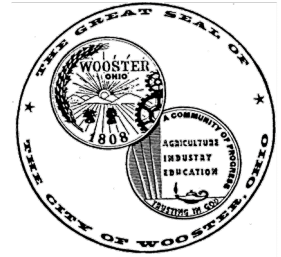

**REQUEST FOR EXTENSION OF TIME TO FILE**

This extension does not extend the due date for tax due for 2022 or any estimated taxes for 2023.

1. I request an extension of time until \_\_\_\_\_, 2023 to file my City of Wooster income tax return for 2022.
2. The extended date requested should be no later than October 15, 2023.
3. No late filing penalty will be charged; however, penalty and interest shall be calculated on any amount due.

**DECLARATION OF 2023 WOOSTER INCOME TAX ESTIMATE**

**Due on or before April 18, 2023**

Extension of time to file a tax return does not apply to a declaration of estimated tax or payment of quarterly installments

The tax rate for 2023 is 1.5%. The City of Wooster allows 100% credit for taxes paid to another city up to 1.5%

5. A declaration of estimated tax should be filed, and quarterly estimates made for 2023 to avoid penalty and interest for any taxpayer required to pay 2023 estimated taxes. A taxpayer is required to pay estimated taxes if their tax liability, less credit for Wooster taxes withheld and/or taxes paid other cities, will equal or exceed \$200.

**2022 NON-RESIDENT INDIVIDUAL NON-FILING DECLARATION**

**Due on or before April 18, 2023**

Non-residents who received a Wooster income tax return in the mail or filed a 2021 tax return and are not required to file a 2022 Wooster tax return, should complete this non-filing declaration in lieu of filing a tax return.

I/we were not residents of Wooster at any time in 2022, any wages earned within the City of Wooster had Wooster income tax withheld at a rate of 1.5% or greater, and I/we had no business or rental activity within Wooster in 2022.
